Water Monkey Camp Participant Agreement and Liability Waiver

I, _____, (parent/guardian), for myself, any other parent and the participant, in connection with my son/daughter, _____ ("the participant"), attending and participating in Water Monkey Camp, hereby agree as follows: I understand that there are certain dangers, hazards and risks (foreseen and unforeseen) inherent in attending and participating in Water Monkey Camp, including, without limitation, risks related to water sports, use of equipment and facilities, personal safety (including risks of minor, serious or mortal personal injury) and risks of property damage. In recognition of the above risks, I confirm that the participant is physically and mentally capable of attendance and participation in all activities and use of all equipment associated with Water Monkey Camp. The participant is willingly and voluntarily attending and participating, and I agree that the participant and I shall assume all risks inherent in, arising from, or related to the participant's attendance and participation in Water Monkey Camp.

The participant and I agree that during attendance and participation in Water Monkey Camp, which may include travel to and from Water Monkey Camp, the participant will abide by the instructions of any Water Monkey Camp personnel and will comply and follow the rules and regulations of Water Monkey Camp. Water Monkey Camp reserves the right, at their sole discretion, to withdraw any camper whose influence and actions are deemed unsatisfactory to the best interests of the camp or who will not live within the rules and policies of the camp. If this occurs, no reduction or return of fee, or any part thereof, will be made. No refunds or reductions of fee can be made for entering or withdrawing early. In the case of a cancellation Water Monkey Camp tuition is non-refundable.

WAIVER OF WATER MONKEY CAMP LIABILITY/RELEASE AND HOLD HARMLESS

In consideration of the attendance and participation in Water Monkey Camp, and knowing the dangers, hazards and risks (foreseen and unforeseen) of attending and participating in Water Monkey Camp, the Undersigned, for themselves, any other parent and the participant, understand(s) and agree(s) to RELEASE AND HOLD HARMLESS Water Monkey Camp and its current and former officers, directors, employees, attorneys, sponsors, representatives, property owners/managers and agents and waive any claim for injury and damage resulting from the participant's attendance and participation in Water Monkey Camp.

Water Monkey Camp will not be held responsible for campers' personal property that is damaged, lost, or stolen while at camp.

ACKNOWLEDGEMENT

It is the express intent of the Undersigned that this Agreement shall bind the Undersigned, any other parent, and the participant. The Undersigned acknowledges that they have read and understand this document and the RELEASE AND HOLD HARMLESS provisions. The Undersigned agrees that this Agreement shall be construed in accordance with the laws of the State of New Hampshire, without giving effect to the conflict of laws provisions thereof, and that the State of New Hampshire shall be the forum for any lawsuits filed under or incident to this Agreement. The terms and provisions of this Agreement shall be severable, such that if a court of competent jurisdiction holds any term to be illegal, unenforceable, or in conflict with any law governing this Agreement the validity of the remaining portions shall not be affected thereby, and each and every term and condition of this Agreement shall be valid and enforced to the fullest extent and in the broadest application permitted by law.

The above named participant has my permission to participate in the camp program above. I grant Water Monkey Camp consent to administer over the counter medications and to treat participant in the case of any illness or injury. In the event I cannot be reached in an emergency when participant is under Water Monkey Camp supervision, I give my permission to the attending physician to render any and all medical treatment to the participant, including (if necessary) hospitalization.
